



## MEMORANDUM OF UNDERSTANDING (MoU)



between

Vasanta College for Women, Rajghat Fort, Varanasi  
and  
DAV PG College, Varanasi

The general objective of this Memorandum of Understanding (MOU) is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the intellectual life and cultural development of both campuses, and to contribution to increased institutional cooperation. Thus, **Vasanta College for Women, Rajghat Fort, Varanasi** and **DAV PG College, Varanasi** have agreed that in support of their mutual interests in the field of education and research:

### 1. The two Educational Institutions will:

- a) Cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests;
- b) Promote appropriate joint research projects and joint courses of study, with particular emphasis on Govt. funded projects;
- c) Conduct cultural programs, a, mutually agreed in writing between the parties prior to commencement of this activity;
- d) Conduct study tours, a, mutually agreed in writing between the parties prior to commencement of this activity.
- e) Training and development of administrative and technical staff.
- f) The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both colleges.
- g) The host institution agrees to assist in the seeking of appropriate housing, and to supply work space, library and technical facilities as appropriate.
- h) In the implementation of specific cooperative programs, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party will be negotiated, mutually agreed and formalized in writing, prior to the commencement of the program.

## 2. Effective Dates and Amendments

This agreement will take effect from the date of its signing and shall be valid for five (5) years from that date of agreement unless sooner terminated, revoked or modified by mutual written agreement between two Parties, and may be extended by mutual written agreement.

Either party may terminate the Agreement at any time during the term by the provision of one month (30 days) written notice to the other party.

## 3. Relationship

Nothing in this MOU shall be constructed to make Party, a partner, an agent or legal representative of the other for any purpose.


