- Mutually Agreed for the Rates and facilities.

### 3. EFFECTIVE DATES AND AMENDMENTS

- This MOU shall take effect upon signing by both Parties and shall remain in effect for a period of Five (5) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.


- b) The MOU may be renewed at the end of this period by mutual written agreement by both Parties.

**4. RELATIONSHIP**


Nothing in this MOU shall be constructed to make Party, a partner, an agent or legal representative of the other for any purpose.
