## MEMORANDUM OF UNDERSTANDING (MOU)

The agreement made and entered into on 01 day of November, 2021 between DAV PG COLLEGE, AUSANGANJ, VARANASI (hereinafter referred as DAV) and "SAI GIRLS HOSTEL, K 54/4 DARANAGAR, VARANASI" (hereinafter referred as SAI) situated at Varanasi, Uttar Pradesh, India.

### 1. PURPOSE OF THE MOU

### 2. PROPOSED MODE OF COLLABORATION

- Mutual visits of academic & Non-academic staff.
- Security facilities provided by the SAI and monitored by DAV time to time.
- Promoting mutual facilities for the benefits of the Girl Students as and when required.
- Mutually Agreed for the Rates and facilities.

### 3. EFFECTIVE DATES AND AMENDMENTS

- This MOU shall take effect upon signing by both Parties and shall remain in effect for a period of Five (5) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.

- b) The MOU may be renewed at the end of this period by mutual written agreement by both Parties.
- c) The provisions of this MOU may only be amended or waived by mutual agreement by both Parties.
- d) DAV Solely authorized to terminate this MOU and any related agreement against the reasonable complaint of the Student by giving thirty (30) days prior written notice to the other Party.

**4. RELATIONSHIP**


Nothing in this MOU shall be constructed to make Party, a partner, an agent or legal representative of the other for any purpose.
